There were 76 inspections completed and 2 meetings attended during this time period.

HEALTH, ENVIRONMENT AND INSURANCE - Lorraine H. Briggs

Solid Waste Management - Trustee Briggs reported that compared to one year ago 120,000 pounds more solid waste had been recycled in August, 1997.

BUILDING AND GROUNDS - Francine R. Fossler

Village Hall/IDOT MFT Resolution - Trustee Fossler motioned to pay the third payment of \$10,836.15 from the Motor Fuel Tax Fund to the Treasurer, State of Illinois for the construction on the Village Hall property. Trustee McManus seconded. Roll Call.
