McLaughlin, Walsh, and Konicek attended recent BACOG Emergency Management session. About 82 participants. These are a few of the emergency items that are continually addressed by elected officials. State trend is to coordinate, not create, so these exercises will continue. Ongoing communications with safety personnel. Also of note is that Barrington Countryside Fire Protection District is leaving CenCom E9-1-1 looking at other options including Quadcom.

Harrington inquired if we have participated in train spill planning. The Village has been part of community discussion to improve rail safety.

After researching Village appointments in the past, it has been determined by counsel that they were not done correctly. Boards, specifically the Zoning Board of Appeals, are supposed to be staggered. Zoning Board was established with stagger, after initial stagger then to have 5 year term, allowing for continuity. Prior Counsel reviewed in 2010 found issues. Fixing the broken stagger can be done by an amendment to Code 2-4-1 to allowing for correction of required stagger.

The Village will work with attorney to make determination of who is properly seated, with appointments at meeting following conclusion.
