Dispatch Consolidation Update

Richard Tuma is on the project management team with PCS solutions working with the Police Department on the consolidation. Tuma reports that of the 56 total tasks, 60% are complete. The cut over is currently scheduled for October 27th at 10am. Chief reports that there are only 16 residents remaining that have not made the alarm changes yet. At this point the consolidation project has been well under budget.

Croll reviews that the Board has been analyzing whether the Village should take out a pension obligation bond to fund the police pension fund. The Board is reviewing this option to possibly lower the Villages total contribution to the fund. The risk would be not meeting the expected returns.

John Peterson and Mike McIntyre of William Blair & Co. spoke regarding the bond.

McIntyre reviewed the process and options for the Village. Stating that there are, of course, many variables.

Croll reviews the resolution before the board to spend up to \$23,500.00 with William Blair & Company to set up the bond.

The estimates are that the Village could save between \$4-4.5 million in the long run depending on returns.

McLaughlin brings forward that this will be a 25 year program and it will take a long period of time before we can determine if this was a favorable outcome if we decide to proceed.

Konicek asks what time frame of Bond issuance. Peterson reviews that it usually takes a couple of months to put it together after approval. Likely looking towards a January date.

Harrington reviews that he is happy that the Board is discussing in detail the possible negative outcomes as well as the positives.

Croll brings forward that he wishes that the Village request public input at the next Finance Committee Meeting before making a decision.
