

**AN ORDINANCE AMENDING SECTION 4-2-1 OF THE WATER WELL CONSTRUCTION  
SECTION OF THE BUILDING CODE**

**WHEREAS**, the Village of Barrington Hills ("Village") is a duly organized and existing Illinois home rule municipality pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

**WHEREAS**, Section 4-2-1 of the Village Code of the Village of Barrington Hills ("Village") and Sections 5/11-30 *et seq.* of the Illinois Municipal Code, 65 ILCS 5/11-30 *et seq.* authorize the Village Board of Trustees to regulate buildings in the Village and adopt Building Codes for the Village; and

**WHEREAS**, Section 4-2-6 of the Village's Building Code adopts the Illinois Water Well Construction Code 415 ILCS 30/1 by reference with such additions as are provided in said Section 4-2-6; and

**WHEREAS**, the Village desires to specify the construction and maintenance requirement of a potable water well by amending Section 4-2-6(C).

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Barrington Hills, Cook, Kane, Lake and McHenry Counties, Illinois, as a Home Rule municipality, the following:

**Section One:** Incorporation of Preamble: The Village Board hereby finds that the recitals contained in the preamble to this Ordinance are true and correct and does incorporate them into this Ordinance by reference.

**Section Two:** Sections 4-2-6(C) shall be, and hereby is deleted in its entirety and the following shall be inserted in lieu thereof:

(C) Construction and Operation: The designated enforcement officer of this Code is herein referred to as the local authority and shall mean the Building Officer of the Village.

1. The Building Officer shall be provided with adequate proof of compliance with this section prior to the issuance of a building permit.

2. The owner of a potable well shall provide the Building Officer assurance of a potable water supply by producing a water sample as the term is defined in the referenced Code.

**Section Three:** Validity: Should any part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of this Ordinance as a whole or any part thereof other than the part declared to be invalid.

**Section Four:** Superseder and Effective Date: All ordinances, resolutions, motions and orders thereof, in conflict herewith are to the extent of such conflict hereby superseded; and this Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
