

**A RESOLUTION CONCURRING WITH THE ILLINOIS DEPARTMENT OF TRANSPORTATION'S AWARD TO COPENHAVER CONSTRUCTION OF GILBERTS, ILLINOIS FOR PURPOSES OF THE CUBA ROAD BRIDGE REPAIR WORK**

**WHEREAS**, the Village of Barrington Hills ("Village") is a home-rule municipality pursuant to Article VII, Section 6, of the Constitution of the State of Illinois, and as such is authorized to take all reasonable action pertaining to its affairs in accordance therewith; and

**WHEREAS**, the Village has previously entered into an agreement with the Illinois Department of Transportation ("IDOT") for improvement to the Cuba Road Bridge under a local agency agreement, for cost sharing of said work; and

**WHEREAS**, IDOT recently placed the Cuba Road Bridge project for bid, and secured construction bids from five bidders; and

**WHEREAS**, of the bidders, Copenhaver Construction of Gilberts, Illinois submitted the lowers bid for the project, in the amount of \$1,103,631.55, and IDOT has deemed Copenhaver Construction the lowest qualified bidder on the project; and

**WHEREAS**, IDOT has reported the results of the bid opening to the Village, and has requested concurrence in the bid award to Copenhaver Construction of Gilberts, Illinois.

**NOW, THEREFORE, BE IT RESOLVED** by the President and Board of Trustees of the Village of Barrington Hills, located in the Counties of Cook, Kane, Lake and McHenry, Illinois, as follows:

**SECTION ONE:** The recitals set forth above are incorporated herein and made a part hereof.

**SECTION TWO:** The Village President and Board of Trustees hereby concurs in the award of the bid as set forth herein to Copenhaver Construction of Gilberts, Illinois.

**SECTION THREE:** The Village Clerk shall forward a certified copy of this Resolution to Village Engineer Dan Strahan of Gewalt Hamilton & Associates, Inc., 625 Forest Edge Drive, Vernon Hills, IL 60061 so that he may forward this Resolution to the appropriate staff at the Illinois Department of Transportation.

**SECTION FOUR:** This Resolution shall take effect immediately upon its passage and approval as provided by law.

On Friday, September 18<sup>th</sup>, 2015 the Illinois Department of Transportation (IDOT) received bids for the Cuba Road Bridge Replacement Project in Barrington Hills. As 80% of the construction costs will be paid for through federal Highway Bridge Program funds, the project was bid by IDOT and will be awarded by IDOT. The construction costs will be paid for by IDOT, with 20% reimbursement from the Village as the project proceeds.

Five bids were received for the project. The apparent low bidder is Copenhaver Construction of Gilberts, IL, submitting a bid of \$1,103,087.10. The second low bidder is Lorig Construction Company of Des Plaines, IL at \$1,225,324.30. The final Engineer's Opinion of Probable Cost for the project was \$1,016,106.25. The bid tabulation in IDOT format is attached and summarized below for clarity:

### Contractor Review

Copenhaver Construction, Inc. has completed multiple projects for the Village in the past, most recently the 2015 Merri Oaks Road Drainage Improvements project. Copenhaver also completed drainage projects for the Village of Barrington Hills in 2009 and 2011.

Per the attached email, IDOT is requesting the concurrence of the Village in awarding the contract to Copenhaver Construction, Inc. in the amount of \$1,103,087.10. The Village's share (20%) of the construction cost totals \$220,617.42.

We recommend that the Village concur with the award of the Cuba Road Bridge Replacement project to Copenhaver Construction, Inc.
