Re: 2015 Old Hart Road Bridge Repairs

Bid Recommendation

Dear Mr. McLaughlin:

On Tuesday, September 22, 2015 at 2:00 PM bids for the above referenced project were received, opened and read aloud at the Village Hall. Attached is the bid tabulation and summary of the bids received. The project includes structural repairs to the Old Hart Road bridge as recommended by Wiss Janney Elstner Associates (WJE, the Village's Bridge Program Manager) as well as associated guardrail improvements.

Four bids were received for the project. The low bidder was Alliance Contractors of Woodstock, IL. Alliance submitted a bid of \$87,605.00. Kovilic Construction of Franklin Park, IL submitted the second lowest bid at \$91,225.00. Bids received ranged from \$87,605.00 to \$105,900.00. A detailed cost estimate was not prepared prior to the bid, but WJE had projected a construction cost of approximately \$35k-\$50k for the concrete repairs only.

Alliance Contractors has worked previously in the Village, completing the 2006 Cuba Road bridge repair project as well as the Algonquin Road culvert project in 2008. Our office has worked with them on several other projects in the area over the past several years and have found them to be an excellent contractor to work with.

We recommend that the Village Board award the 2015 Old Hart Road Bridge Repair work package to Alliance Contractors in the amount of \$87,605.00.

Lastly, as with any other construction project, it is recommended that the Village Board factor in a 10% contingency factor for additions or changes due to unforeseen conditions (generally below grade) to the proposed construction improvements. As always our office will keep the board apprised of any significant changes in the project scope. We anticipate the project will be completed in late October or early November. The contract documents specify a completion date of November 20, 2015.
