Approve Ordinance Granting a Special Use Permit Allowing for the Expansion of an Existing Artificial Lake at 153 Algonquin Road

Trustees discussed the ordinance. Issues such as large items, and that some current bins won't fit lids, were brought forward. Harrington recalled reviewing the possibility of contracting with a single hauler during his time working with HEC. The company would provide closed bins at low or no cost, recycling containers would be mandatory, leading to more people recycling.
