Background on Resolution for Mobile Video Storage Solution

The Mobile-Vision video storage solution consists of hardware and software utilized for organizing, managing, and archiving video recorded on in-car Mobile-Vision Flashback mobile video recorders, which are installed in all fleet units utilized for patrol. The hardware portion of the system primarily consists of a data storage server and a "DVD robot" which burns files to DVD for physical backup and/or for use in court. Both of these hardware components have reached 'end of life' status and are no longer able to be warrantied.

The Resolution before you requests BOT approval to purchase this system at a cost not to exceed \$14,000. This expenditure was planned and included in the 2017 budget.

A RESOLUTION AUTHORIZING THE PURCHASE OF AN UPGRADE TO THE EXISTING VIDEO SERVER AND VIDEO STORAGE EQUIPMENT LOCATED AT THE VILLAGE POLICE DEPARTMENT FACILITY

WHEREAS, it is the recommendation of the Village Police Department that the Village President and Board of Trustees authorize the purchase of an upgrade to its existing video server and video storage equipment at the Village Police Department Facility at an expense not to exceed \$13,937.90; and

WHEREAS, based on the recommendation of the Village Police Department, the President and Board of Trustees has determined the purchase of an upgrade to its existing video server and video storage equipment at the Village Police Department Facility, at an expense not to exceed \$13,937.90, is in the best interests of the citizens of the Village.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, located in the Counties of Cook, Kane, Lake and McHenry, Illinois, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: The Chief of Police is authorized to purchase of an upgrade to its existing video server and video storage equipment at the Village Police Department Facility, at an expense not to exceed \$13,937.90, to be taken from the Village General Fund.

SECTION THREE: This Resolution shall take effect immediately upon its passage and approval as provided by law.
