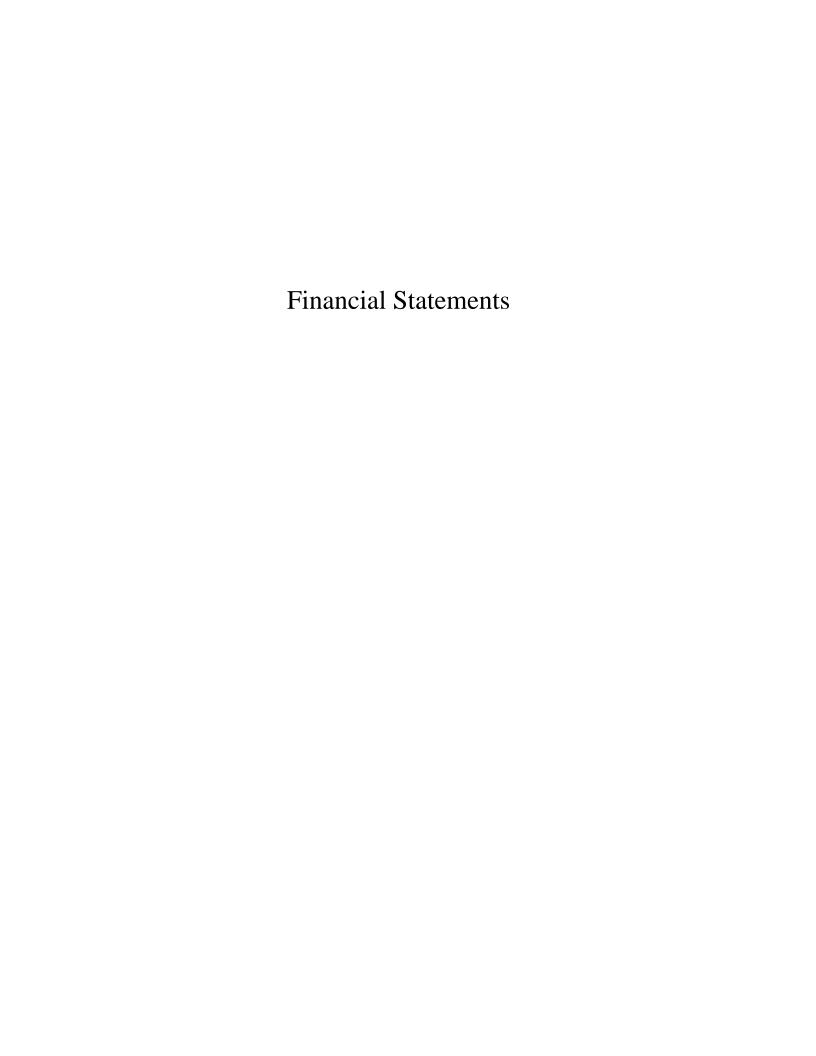

Barrington Hills Police Pension Fund Statement of Net Position - Modified Cash Basis As of October 31, 2015

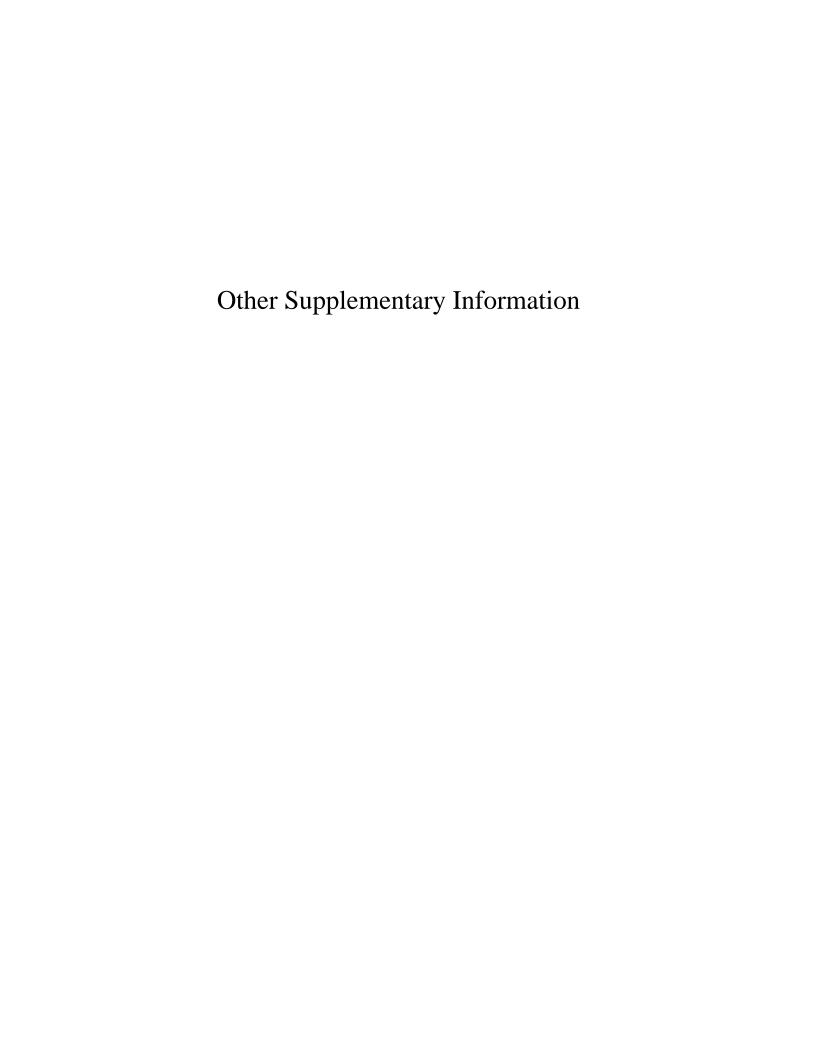


