Per your request, here is a summary of our costs:

- Currently \$32.20 every two (2) months. This will increase by 50 cents per month beginning in September, so the new cost for our residents will be \$33.20 every two (2) months.
- For this amount, they receive: a 95 gallon garbage tote; a 35 or 65 gallon recycle tote; free pick up of 1 bulk item per week; and 4 free yard waste bags. We think, and our residents agree, that it's a pretty good bargain.
