

RESOLUTION 11-__

**A RESOLUTION AUTHORIZING THE TORCH RUN
BY THE VILLAGE OF BARRINGTON HILLS**

WHEREAS, in the opinion of the corporate authorities of the Village of Barrington Hills (the "Village"), it is for the best interests of the Village to hold the Annual Illinois Special Olympics Torch Run ("Torch Run") on the route attached hereto as Exhibit "A" (the "Marked Route") beginning at 8:00 a.m. on June 5, 2011; and

WHEREAS, the Torch Run will require the partial or complete closing of the streets located on the Marked Route; and

WHEREAS, pursuant to Section 5/4-408 of the Illinois Highway Code (605 ILCS 5/4-408), the Village is required to assume all responsibility and liability involved in the closing of any portion of a State highway.

NOW, THEREFORE, BE IT RESOLVED, by the President and Board of Trustees of the Village, located in the Counties of Cook, Kane, Lake, and McHenry in the State of Illinois, a home rule municipality as follows:

Section 1. Recitals. The foregoing recitals are hereby incorporated into this Resolution as findings of the President and Board of Trustees.

Section 2. Responsibility and Liability. The President and Board of Trustees agree that the Village will assume full responsibility for the direction, protection and regulation of traffic during the time the detour is in effect, and all liabilities for damages of any kind occasioned by the closing of said Marked Route.

Section 3. Detours. The President and Board of Trustees further agree that efficient, all weather detours will be maintained conspicuously marked and judiciously police patrolled for the benefit of traffic deviated from the, Marked Route.

Section 4. Effective Date. This Resolution shall be in full force and effect from and after its passage, approval and publication according to law.



Please be advised that Leg 15 of the 2010 Illinois Law Enforcement Torch Run Benefiting Special Olympics Illinois is schedule for June 5, 2011, at 0800 Hours.

The Run will begin at the Barrington Hills Police Department and travel west on Route 62 through our Village to Route 31, in Algonquin, and then end at Knox Park on Route 31 in McHenry, Illinois.

I am requesting that our Village acquire the proper permits necessary for this event, for Route 62, from Route 59 to Route 25, at our western border.

In 2010, the Illinois Law Enforcement Torch Run Program raised over \$2 Million. It is the Goal of the Torch Run Program to maintain that \$2 Million mark and continue to raise additional funds to support Special Olympics Illinois.
