START: Mag Nail, S curb Main St., 28' W of light pole EM5F at SW corner of Main & Cook.

1 MILE: S edge Main St., 56' W of and across road from 3rd utility pole W of entrance to Flint Creek Corporate View office park.

2 MILE: S edge County Line Road, 8' W of and across street from utility pole 13348- 1st utility pole W of entrance to 27W674/676.

3 MILE: E edge Brinker Rd., N of Otis, 34.5' N of 5th utility pole on E side of road N of Otis.

5 KILOMETER: N edge Otis Rd., 83' E of center of drain grate at NE corner of Otis and Brinker.


4 MILE: S edge Otis Rd., 39' E of utility pole at 26W819- just e of concrete silos at Hawley Woods Rd.

5 MILE: N edge Skyline Dr., across from 215, 11.5' NW of center of "SANITARY" manhole cover in middle of street.

6 MILE: S edge Lincoln, even with utility pole between 312 and 316.

FINISH: Mag Nail, even with point in parking "island" and light pole P3M in front of entrance to 205 Park Ave.

RESOLUTION 13 -

**A RESOLUTION AUTHORIZING ADVOCATE HEALTH CARE NETWORK
“THE RUN FOR THE ARTS” RACE
BY THE VILLAGE OF BARRINGTON HILLS**

WHEREAS, in the opinion of the corporate authorities of the Village of Barrington Hills (the "Village"), it is for the best interests of the Village to hold its “Run for the Arts” Race on the route attached hereto as Exhibit “A” (the “Marked Route”) BEGINNING AT 7:15 a.m. on July 4, 2013; and

WHEREAS, the “Run For The Arts” will require the partial or complete closing of the streets located on the Marked Route; and

WHEREAS, pursuant to Section 5/4-408 of the Illinois Highway Code (605 ILCS 5/4-408), the Village is required to assume all responsibility and liability involved in the closing of any portion of a State highway;

NOW, THEREFORE, BE IT RESOLVED, by the President and Board of Trustees of the Village of Barrington Hills, a home rule municipality located in the Counties of Cook, Kane, Lake, and McHenry in the State of Illinois, as follows:

Section 1. Recitals. The foregoing recitals are hereby incorporated into this Resolution as findings of the President and Board of Trustees.

Section 2. Responsibility and Liability. The President and Board of Trustees agree that the Village will assume full responsibility for the direction, protection and regulation of traffic on the Marked Route during the time the detour is in effect, and all liabilities for damages of any kind occasioned by the closing of said Marked Route.

Section 3. Detours. The President and Board of Trustees further agree that efficient, all weather detours allowing traffic around the Marked Route. Such detours conspicuously marked and judiciously police patrolled by the Village Police Department for the benefit of traffic detouring from the Marked Route.

Section 4. Effective Date. This Resolution shall be in full force and effect from and after its passage, approval and publication according to law.
