VILLAGE OF BARRINGTON HILLS SUPPLEMENTAL APPROPRIATION ORDINANCE – 2011 CORPORATE FUND PETROLEUM SUPPLIES

WHEREAS, the Village of Barrington Hills adopted Appropriation Ordinance 11-11 for the fiscal year commencing January 1, 2011, and ending December 31, 2011; and

WHEREAS, the Village has determined that it is necessary to transfer funds within the Corporate Fund to pay the costs of additional Petroleum Supplies;

WHEREAS, pursuant to 65 ILCS §8-2-9, the Village of Barrington Hills may make transfers of sums appropriated for one corporate object to another; and

WHEREAS, it has been deemed necessary to adopt an ordinance making a supplemental appropriation to defray the expenses of the Village of Barrington Hills, Cook, Kane, Lake and McHenry Counties, Illinois, designated the "Supplemental Appropriation Ordinance" for the fiscal year commencing January 1, 2011 and ending December 31, 2011.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington Hills, Cook, Kane, Lake and McHenry Counties, Illinois, as a home rule municipality, the following:

Section 1: That for the purpose of defraying all the necessary expenses and liabilities of the Village of Barrington Hills for the fiscal year commencing January 1, 2011, and ending December 31, 2011, the additional sums of money, or so much thereof as may by law be authorized for expenditure in the Corporate Fund, be and the same are hereby set aside and appropriated for the following purposes, to wit:

Public Safety

Amount

Petroleum Supplies

\$ 20,000

Section 2: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
