A RESOLUTION AUTHORIZING THE EXECUTION OF A SETTLEMENT AGREEMENT AND MUTUAL RELEASE OF THE LITIGATION ENTITLED, JAMES J. DRURY, AS AGENT OF THE PEGGY D. DRURY DECLARATION OF TRUST U/A/D 02/04/00, JACK E. REICH AND JAMES T. O'DONNELL V. VILLAGE OF BARRINGTON HILLS, CASE NO. 2015 CH 3461

**SECTION ONE:** The recitals set forth above are incorporated herein and made a part hereof.

**SECTION TWO:** The Village President is hereby authorized and directed to execute on behalf of the Village of Barrington Hills, the Settlement Agreement attached hereto and incorporated herein by reference as Exhibit "A," and the Village Clerk is authorized to attest thereto.

**SECTION THREE:** This Resolution shall take effect immediately upon its passage and approval as provided by law.
