SUMMARY September 2014

D.U.I. ARRESTS:

Department personnel made 2 D.U.I. arrests in September.

BARRINGTON HILLS POLICE DEPARTMENT Monthly Report September 2014 Summary of Activity

Theft

A resident reported the theft of prescription medication from the home. It is suspected that a former caregiver may be the offender. The former caregiver denied any knowledge of the theft.

Fraud

A resident reported that she had answered an ad on Craigslist regarding a home for rent. The complainant advised that after she had wired money for a down payment she became suspicious and stopped all communication.

A resident reported receiving a phone call from someone claiming to be with the IRS. The resident reported that they knew it was a scam, and wanted the police department to be advised.

Damage to Property

A property owner reported that his tenants had a party and there was significant lawn damage due to a vehicle "doing donuts" in the yard. The property owner stated that the tenants are going to forward the name of the offender so that he could seek restitution. He advised that he did not want any police action at this time, only documentation. No further action taken.

Criminal Trespass to Property

A property manager reported two subjects, possibly late teens, were at a vacant home that is for sale. The complainant reported that the subjects fled in their vehicles when she arrived at the home. The home was placed on an extra watch.

DUI / No DL / Suspended / Revoked DL / Possession of Cannabis

DUI arrests – 2 citations; No Valid Driver's License – 3 citations; Suspended/Revoked Driver's License – 2; Suspended Registration – 1 arrest

Harassment

A resident reported she has been receiving harassing / threatening calls and text messages from an ex-boyfriend. At this time, the complainant only wanted the incidents documented. She advised if she wanted the police to contact the offender, she'll let BHPD know. The officer explained the process of getting an order of protection, and placed the home on an extra watch.

A resident reported receiving harassing calls from a subject stating that her loan had been approved. The complainant reported that she has not applied for any loans. The officer called

the subject back and advised him to cease any further calls to that number. No further action at this time.

Disorderly Conduct

Some residents came into BHPD after a village meeting and stated that they felt threatened by a neighbor by statements he made after the meeting. The complainants did not want to pursue charges, but wanted the incident documented in case there are future incidents.

Domestic

Officers responded to one domestic during this reporting period. It was verbal in nature. Both parties agreed to stay separated for the night. Domestic violence handbooks were issued. No further action taken.

Lockout

Officers responded to three vehicle lockouts and one residential lockout. Entry was gained.

Alarms

Officers responded to three burglar alarms with unsecured doors. The premises were checked for signs of burglary and key-holders were notified.

Lost Property

A resident reported one of her license plates is missing. She is not sure if it fell off or if it was stolen. The license plate was entered into LEADS as lost or stolen.

Task Force Activity

The Major Case Assistance Team was activated by Hanover Park PD for a homicide investigation.

Child Custody Exchange

Officers stood by for two child custody exchanges. No problems were observed.

Animal Incidents

Four stray dogs were picked up by BHPD. Two were claimed by their owners and two were transferred to Golf Rose Kennel.

Two injured deer were terminated.
