## ORDINANCE AMENDING CHAPTER 5 OF TITLE 4 OF THE VILLAGE CODE

WHEREAS, the Village of Barrington Hills (the "Village") has adopted Chapter 5 of Title 4 of the Village Code (the "Flood Ordinance") in order to comply with the National Flood Insurance Program of the Federal Emergency Management Agency ("FEMA"); and

WHEREAS, the President and the Board of Trustees of the Village find and believe it to be in the best interest of the Village that certain portions of the Flood Ordinance be amended as provided in this Ordinance in order to update the Flood Insurance Rate Maps prepared by FEMA.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington Hills, Cook, Kane, Lake and McHenry Counties, Illinois, as a home rule municipality, the following:

<u>Section 1.</u> <u>Incorporation of Preambles</u>. The Village Board hereby finds that the recitals contained in the preambles to this Ordinance are true and correct and does incorporate them into this Ordinance by this reference.

<u>Section 2.</u> Flood Insurance Rate Map. Sections 4-5-3 17(a) and (b), Sections 4-5-3 30(a) and (b), and Sections 4-5-6(A) and (B) of the Flood Ordinance shall be, the same is hereby amended by deleting the reference to the "Flood Insurance Rate Map dated November 16, 2006", and replacing the same with a reference to the "Flood Insurance Rate Map prepared by the Federal Emergency Management Agency, in effect from time to time as listed in Appendix A to this ordinance, as maintained by the Village Clerk".

<u>Section 3.</u> <u>Appendix A</u>. Appendix A attached to this ordinance is hereby adopted to reference the correct Floor Insurance Rate Maps and Flood Insurance Studies for those portions of the Village in Cook, Kane, Lake and McHenry Counties and may be amended from time to time. Appendix A is hereafter a codicil to the Flood Ordinance.

<u>Section 4.</u> <u>Validity</u>. Should any part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of this Ordinance as a whole or any part thereof other than the part declared to be invalid.

Section 5. Superseder and Effective Date. All resolutions, motions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded; and this Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
