

**AN ORDINANCE AMENDING TITLE 2, CHAPTER 8
OF ITS CODE OF ORDINANCES
REGARDING THE CREATION AND PURPOSE OF THE
VILLAGE'S EQUESTRIAN COMMISSION**

WHEREAS, the Village of Barrington Hills (hereinafter the "Village") is a duly organized and existing Illinois home rule municipality pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

WHEREAS, the Village of Barrington Hills is authorized and empowered, under its home rule powers and the Code of Ordinances of the Village of Barrington Hills, to create and regulate various boards and commissions to serve as advisory bodies to the Village Board; and

WHEREAS, in furtherance of this authorization, the Village Board authorized creation and organization of an Equestrian Commission, whose powers and duties are set forth in Title 2, Chapter 8 of the Code of Ordinances of the Village; and

WHEREAS, review of Title 2, Chapter 8 has led to suggestions to revise Chapter 8 to conform the creation, purpose and powers to the needs of the Village Board, set amendment to the existing text being set forth hereinbelow; and

WHEREAS, the President and Village Board of Trustees has considered the matter and determined that the proposed text amendment to Title 2 Boards and Commissions, Chapter 8 Equestrian Commission, be approved, as such action is believed to be in the best interests of the Village and its residents.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington Hills, a home rule community located in Cook, Lake, Kane and McHenry Counties, Illinois, duly assembled at a regular meeting, as follows:

SECTION ONE: That the forgoing recitals are hereby incorporated by reference as if fully set forth herein.

SECTION TWO: That Title 2 Boards and Commissions, Chapter 8 Equestrian Commission, be revised to state as follows:

2-8-1: CREATION AND PURPOSE:

In order to protect the public health and welfare of the residents of the village and to provide expertise in the area of best equine management practices and equestrian activities within the village to the village board, various village committees and village staff, the equestrian commission is hereby created pursuant to the authority of section 11-16-1 of the Illinois municipal code.

2-8-4: POWERS AND DUTIES:

The equestrian commission shall have the following powers and duties:

...

(B) Provide recommendations for trail design, trail routing and trail signage as permitted.


SECTION THREE: That all other ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance, are, to the extent of such conflict, expressly repealed.

SECTION FOUR: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
